The AIUM's Ultrasound Practice Accreditation Council Announces Accreditation of Santé Comprehensive Women's Healthcare

The AIUM developed this program in response to the many changes in the approach to healthcare delivery that have resulted in an increased scrutiny of diagnostic evaluations, as well as technical improvements that have allowed for the expanded use of ultrasound and have dramatically increased the number of physicians and sonographers using this modality.
